The Board proceeded to business - and first

Took into consideration the Petition of the Hon^{ble}
Felix O'Hara Esq^r praying for one hundred acres of
land at Perce so as not to interfere with the usual
Privileges of the British Fisheries nor priority of Possession
according to a figuratif Plan thereto annexed.

A Petition of Charles Robin on behalf of the
Publick was then read, setting forth the Propriety of
not granting any lands adjoining to the fisheries of
Perce, before a sufficient reserve be made to supply
the same with wood for Skades, Slakes, &c.

Coll. of Ground
The Board having considered the above Petition
they find no objections to grant that of the Hon^{ble}
Felix O'Hara, under the limitations therein mentioned
as soon asth necessary Plan and Report of that Part of
the District is furnished by the acting Surveyor.

The Petition of Daniel McPherson praying for
a Townpark in the Rear of his Townlot in Douglas town
three acres in front by eight in depth -

Granted one acre in front by twenty four in
depth.
